## Explanatory note

The object of this Order is to remake the *Environmental Planning and Assessment (Greater Sydney Region Districts) Order 2016*, which is revoked on the making of this Order, to rename and merge certain districts of the Greater Sydney Region (within the meaning of the *Greater Sydney Commission Act 2015*) for the purposes of Part 3B of the *Environmental Planning and Assessment Act 1979*.

This Order is made under section 75AB (b) of the *Environmental Planning and Assessment Act 1979*.

### 1 Name of Order

This Order is the *Environmental Planning and Assessment (Greater Sydney Region Districts) Order 2017*.

### 2 Commencement

This Order takes effect on the day on which it is published on the NSW planning portal.

### 3 Revocation of Environmental Planning and Assessment (Greater Sydney Region Districts) Order 2016

The *Environmental Planning and Assessment (Greater Sydney Region Districts) Order 2016* published on the NSW planning portal on 11 November 2016 is revoked.

### 4 Declaration of districts

For the purposes of Part 3B of the *Environmental Planning and Assessment Act 1979*, the following districts are declared, with the names specified below, for those parts of the Greater Sydney Region within the local government areas specified next to the name of each district:

- (a) Eastern City District—comprising the local government areas of Bayside, Burwood, Canada Bay, Inner West, City of Randwick, Strathfield, City of Sydney, Waverley and Woollahra,
- (b) Central City District—comprising the local government areas of City of Blacktown, Cumberland, City of Parramatta and The Hills Shire,
- (c) Western City District—comprising the local government areas of Camden, City of Campbelltown, City of Blue Mountains, City of Fairfield, City of Hawkesbury, City of Liverpool, City of Penrith and Wollondilly,
- (d) North District—comprising the local government areas of Hornsby, Hunter's Hill, Ku-ring-gai, Lane Cove, Mosman, North Sydney, Northern Beaches, City of Ryde and City of Willoughby,
- (e) South District—comprising the local government areas of Canterbury-Bankstown, Georges River and Sutherland Shire.

### 5 Continuation of districts

A district declared by this Order (a *new district*) is a continuation of the following former districts:

- (a) for the Eastern City District—the former Central District,
- (b) for the Central City District—the former West Central District,

- (c) for the Western City District—the former West District and South West District,  
and, accordingly, any reference to a former district is taken to be a reference to the relevant new district.
